





#### **FEDERAL**

#### Statements of Interest – Supporting USDA Natural Resources Conservation Services (NRCS) Programs and Partners

The Denali Commission is accepting statements of interest for projects that support and further the goals of USDA Natural Resources Conservation Service. Funds available are intended to build capacity to support NRCS program and partners; build Tribal programs; and support costs for obtaining required permissions for easements and land trusts.

Eligible projects must benefit the public in Alaska

- Funding Opportunity Number: 25-DC-NRCS-SOI-SPP
- . Amount: Award ceiling \$2,500,000, Award Floor \$0
- · Who's it for:
  - · County governments
  - City or township governments
  - · Public housing authorities/Indian housing authorities
  - Non-profit organizations with 501(c)(3) other than institutions of higher education
  - Non-profit organizations without 501(c)(3) other than institutions of higher education
  - Native American tribal organization (other than federally recognized Tribal Governments)
  - Federally recognized Tribal Governments

Note: Entities which do not have an active or pending award with the Denali commission will be prioritized under this funding opportunity.

## DOI Small Surface Water and Groundwater Storage Projects (Small Storage Program)

The Department of Interior's Bureau of Reclamation funds small water storage and groundwater storage projects. Projects funded by the Small Storage Program is designed to enhance water storage opportunities for future generations by funding small surface water and groundwater storage projects. The program funds up to a 25% Federal cost-share to plan, design, and construct surface and groundwater storage projects between 200 and 30,000 acre-feet that will increase water storage or move water to or from a storage project.

The objective is to support stakeholder efforts to stretch scarce water supplies and avoid conflicts over water in the 17 western states. Alaska, and Hawaii.

- Funding Opportunity Number: R25A00270
- Amount: Award ceiling \$30,000,000, Award Floor \$0
- · Who's it for:
  - · Federally recognized Tribal Governments
  - Native American Tribal Organizations (other than federally recognized Tribal Governments)
  - Special Districts
  - · State Governments
  - · County Governments
  - · City or township governments
  - Non-profit organizations\*, other than institutions of higher education à All non-profit organizations must include their 501(c)(3) determination letter issued by the Internal Revenue Service.
- · Application Deadline: April 17, 2026

#### NEVADA

#### Nevada Nonpoint Source Pollution (NPS) Reduction 319(h) Grant

The goals of the Nevada Division of Environmental Protection (NDEP) 319(h) NPS Program within the Bureau of Water Quality Planning (BWQP) is to establish, strengthen, and maintain effective partnerships to achieve the vision of restoring and protecting water quality across Nevada. The 319(h) grant of the NPS Program will support watershed-based plans or implementation projects that mitigate or protect waters from nonpoint source pollution.

The objective of watershed planning helps address water quality problems in a holistic manner by fully assessing the potential contributing causes and sources of pollution, then prioritizing restoration and protection strategies to address these problems. Implementation projects are activities identified in WBPs to protect or restore water quality (e.g., streambank stabilization, low-impact development, rangeland improvements, or conservation easements). These projects should be proposed and completed within the framework of WBPs. However, entities can propose implementation projects in areas where WBPs are not yet available but Alternative Plans apply.

- Funding Sources: US Environmental Protection Agency (EPA)
- · Funding Method: Reimbursement
- Amount: \$25,000-\$500,000 (dependent on project size)
- Who's it for:
  - · Federal, State, local, and Tribal government
  - · Interstate and intrastate public agencies
  - Public and private nonprofit organizations with 501c(3) status
  - Educational institutions à public institutions that are not-for-profit institutions that are barred from lobbying
- Application Deadline: November 3, 2025

#### FY 2026-2027 Sustainable Transportation Planning Grant

The Sustainable Transportation Planning Grant Program was created to support the Department of Transportation (Caltrans) mission of "improving lives and communities through transportation".

Brief Description

**Key Details** 



The objective of the Sustainable Communities grant is intended to support and implement Regional Transportation Plan (RTP) Sustainable Communities Strategies/Alternative Planning Strategies (SCS/APS) and to ultimately achieve the states greenhouse gas (GHG) reduction target of 40%-80% below 1990 levels by 2030 and 2050, respectively. Successful planning projects are expected to directly benefit the multimodal transportation system and improve public health, social equity, environmental justice, the environment, and provide other important community benefits.

- Funding Sources: Department of Transportation (Caltrans)
  - · Sustainable Communities: State Funds (SB1 and State Highway Account)
  - Strategic Partnerships: Federal funds (FHWA SPR Part I)
  - Strategic Partnerships Transit: Federal funds (FTA Section 5304)
- · Funding Method: Reimbursement
- · Match Funding:
  - Sustainable Communities Grants: 11.47% local match requirement.
     Tribal Governments are not required to include a match fund.
  - Strategic Partnerships Grants: 20% local match requirements
  - · Strategic Partnerships-Transit Grants: 11.47% local match requirement
- Amount: \$50,000-\$700,000
- Who's it for:
  - Public agency (e.g., cities, counties, and municipalities)
  - Tribal government

Note: Eligible planning projects must have a transportation nexus per Article XIX Sections 2 and 3 of the California Constitution
